

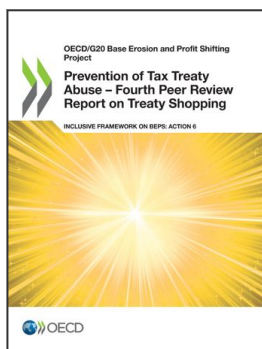
# The Bahamas
