

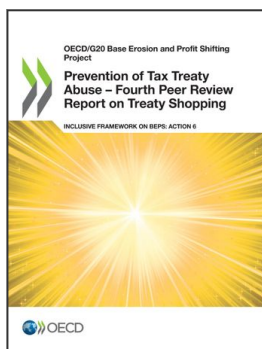
Turks and Caicos Islands
